

account, welcome to working with 4-H Zsuites! It is really pretty easy, so please experiment, and don't be afraid to make mistakes, the program is very forgiving. You'll see a Help option on the left information bar when you get into your account, if you have questions.

**Projects** You will also be able to add projects that your 4-Hers are interested in. When signing up for projects in Zsuites, keep in mind what you might be entering in the county fair, members must be enrolled in the project area to exhibit in that department at the Fair. Please don't sign-up for self-determined unless you have already completed the projects leading up to it.

**New Accounts** Check out these links to create your account or to update your existing account. If you haven't registered previously, when you click "create an account" the Register New Household screen will pop up. You will be asked to pick your state, then you will choose your county, add your household email, to create a password and a pin that is at least 4 characters. Then hit the "Let's Go" button. You will then be sent to a new window, follow the prompts on the screen to create your member profile. If you want to go back to the previous window use the back arrow in the upper left corner. If the screen is not building properly at any time, click the refresh circular arrow also in the top left corner.

For the 2023 New Mexico State Youth Discussion Meet, the NMYF&R will be hosting one state-wide competition. The main details behind this competition are as follows:

- Up to sixty competitors, with a maximum of 8 from each club, chapter, or group, will be allowed to compete.
- Competitors must register with the NMYF&R at the following link, also accessible using the QR code located at the top right of this page: https://www.nmflb.org/Get-Involved/Young-Farmers-and-Ranchers-Program/Competitive-Events
- Registration will be based on a first come, first serve basis. This
  number is based on room and volunteer availability to
  ensure we can hold the competition effectively in a single day.
- Standard Youth Discussion Meet rules, held in previous years, will be adopted. Four contestants will compete in each room, with a thirty second opening statement from each competitor, ten minutes of open discussion, followed by a

one-minute closing statement of each competitor. Competitors will be scored by a team of three judges on a standardized score sheet. The American Farm Bureau Federation 2024 Discussion Meet Questions, attached, will be used as questions, with each round consisting of the same question for all competitors competing in that round.

- The sixty competitors will compete in tournament style rounds, with each competitor competing in at least two rounds before eliminations take place. This will continue, depending on the number of registered competitors, until four competitors are selected to compete in the Final Four competition.
- The general competition will take place Wednesday, November 15th, 2023, at the Embassy Suites by Hilton in Albuquerque, NM. The competition is anticipated to begin at 8:00 AM with orientation, and end with the Final Four competing that evening. Lunch will be provided. This will take place a day before the 2023 NMFLB Annual Meeting. Prizes will be given to each of the final four competitors.

We do apologize for the delay in this announcement but appreciate your patience as we organize this competition. Attached to this letter are the 2024 AFBF Discussion Meet Questions, the 2023 AFBF Discussion Meet Manual (which is modified for use in our competition as detailed above), the 2023 YF&R Discussion Meet Overview Presentation, and a save the date. #### Full Registration Information, Schedule and Workshop Descriptions

#### Cost

\$130.00 per person for 4-H'ers and adults (conference t-shirt, lunch and dinner on Saturday, workshops, facility rentals and program expenses included). Counties will need to arrange and cover their own lodging, dinner on Friday, and breakfasts.

#### **Lodging**

A list of hotels with 4-H blocks will be provided in the full registration. Counties can chose to make reservations at one of those hotels or coordinate their own.

#### **Registration deadlines**

Counties set their own registration deadlines. State 4-H Registration for Counties: December 15

#### **Forms**

- NM 4-H Medical/Liability Release Form Must have one turned into your County Extension Office by the county registration deadline.
- Forms sent in must have signatures. If the signature is electronic, the fourth page showing the signature must be included.

#### **Chaperones**

Adults serving as chaperones for a county must be enrolled in the 4-H program. If not enrolled, they cannot serve as a chaperone. Please make sure they are enrolled before registering them.

#### **Cancellations and Refunds**

- ★ Cancellations and refunds are made only if road conditions in the <u>Las Cruces</u> vicinity are severe. Drivers must make their own travel decisions based on road conditions in their area. We do not want anybody taking unnecessary risks in order to attend this event.
- **★** Refunds cannot be made unless there is a National Weather Service storm warning in existence in the Las Cruces/Dona Ana area.
- ★ If a refund is made due to bad weather, there will be a surcharge deducted to cover actual program expenses incurred up to that point.
- ★ If a cancellation is made prior to the registration deadline, the participant can receive a full refund.
- ★ After registration is closed, if a 4-H'er or adult who is registered cannot attend, a county can substitute another person of the same sex in his or her place, but an actual refund will not be made. If there is no one from your county to fill the spot, please let the state office know before sharing the vacant spot with counties.
- ★ If a cancellation is done after registration is closed due to an emergency or current health issue a full refund will be given to the participant.

# Time to Complete the Annual Working with Minor Training Guidelines for 4-H Volunteers

You may complete the training through the Self-paced model on Zsuites:

https://4h.zsuite.org/

When you are in your 4H ZSuite account and have selected your profile follow the steps below:

- 1. Click on Clover Academy on the left menu bar
- 2. Launch Clover Academy
- 3. Open NM Working with Minors (even though it says completed)
- 4. Under 'You have earned a certificate' is a button that says [Reset All Course Progress for New Year (Cannot be undone.)]
- 5. Click on the blue 'Reset All Course Progress for the New Year (Cannot be undone)'
- 6. Start Course
- 7. Complete the course and a certificate will be available with the completion date. The county 4-H ZSuite administrator should be able to see the volunteer completion on his/her county page. Just a reminder, all of us that work directly with youth need to take the working with minors training annually.
